Our liability and yours is solely limited, to the extent allowed by law, to actual damages, not to exceed the value of any GHG emission reductions purchased, except in cases of gross negligence, willful misconduct or bad faith. These terms and any related agreements between you and Sterling Planet shall not be deemed as creating any rights in any third party, or as giving rise to third party liability.

Assignment - We may assign this agreement to another entity. We will provide you 30 days notice in the event of such an unlikely assignment.

Controlling Provisions - All matters affecting the interpretation of this Agreement shall be governed by and construed according to the laws of the State of Georgia. THERE ARE NO WARRANTIES OR REPRESENTATIONS OTHER THAN THOSE EXPRESSLY SET FORTH HEREIN, AND NO OTHERS SHALL BE HONORED.
